

RESOLUTION NO. R-257529Adopted on NOV 23 1982

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Vertus E. Reinicke	Water Utilities	\$4,290	Mr. Reinicke is an Equipment Operator III in the Systems Division. He suggested that the electric motor on the crane be rewound to slow its R.P.M.s. The first year's experience has shown a savings of \$14,294 in labor and material costs.
John L. Brewer	Fire	\$3,075	Mr. Brewer is a Fire Captain. One year ago he earned a partial award of \$1,925 for his suggestion to relocate the Parts Room at the Repair Facility. One year's experience has shown a savings of \$30,402. This is the remainder of his award.
John R. Crowell	Police	\$1,325	Mr. Crowell is an Evidence Technician in the Crime Laboratory. He suggested that a shuttle system for photographic copy work be established. This is expected to save \$8,838 in the first year in labor and mileage costs. This is a partial award pending a final 12 month review.
Rodger A. Blakey	General Services	\$1,095	Mr. Blakey is a Sign Painter in the Streets Division. One year ago he earned a partial award of \$855 for his suggestion to use high impact styrene plastic rather than aluminum for small sign jobs. One year's experience has shown a savings of \$6,508. This is the remainder of his award.
