Susan E. Roos	Police	\$320	Ms. Roos is a Senior Clerk in the Records Division. One year ago she earned a partial award of \$300 for her suggestion to discontinue transferring information from Hit and Run worksheets to the original reports. One year's experience has shown a savings of \$2,071. This is the remainder of his award.
John R. Crowell Gary F. Avery	Police	\$295	Mr. Crowell and Mr. Avery are Evidence Technicians in the Crime Laboratory. They suggested that contact prints of developed film be printed rather than printing each photograph. This is expected to save \$1,967 in the first year in time, material and equipment costs. This is a partial award pending a final 12 month review.
Beulah M. Unger	Treasurer	\$240	Ms. Unger is an Intermediate Typistin th Licenses Division. She suggested that the subscription rates for the New Business Listing be increased. This is expected to result in an increase in revenue of \$798 in the first year.
Leon E. Byrd	Water Utilities	\$195	Mr. Byrd is a Junior Chemist in the Metro Wastewater Division. He suggested that vinyl tubing for the automatic sampling units be purchased in bulk form. This is expected to save \$647 in the first year in material costs.
