WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

William Nery Charles R. Johnson	General Services Library	\$150	Mr. Nery is an Equipment Repair Supervisor in the Equipment Division and Mr. Johnson is a Senior Typist in the Library. They suggested that unneeded shop manuals from the Equipment Division be transferred to the Library. This is expected to save \$500 in the first year in costs for book purchases.
Cheri J. Paddock	Police	\$ 80	Ms. Paddock is a Senior Clerk in the Records Division. She suggested that crime victims be asked to provide a self-addressed, stamped envelope when requesting copies of their crime reports. This is expected to save \$1,107 in the first year in postage, material and labor costs. This is a partial award pending a final 12-month review.
Robert M. Nichols	Park and Recreation	\$ 60	Mr. Nichols is a Field Representative in the Central Division. He suggested that the daily equipment check-off list be revised to a weekly list. This is expected to save \$200 in the first year in labor and material costs.
George R. Ikeda	General Services	\$ 50	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that metal ball casters be replaced with rubber casters. This is expected to save \$940 in the first year in material costs. This is a partial award pending a final 12-month review.
