David R. Hughey	Water Utilities	\$ 50	Mr. Hughey is a Water Utility Supervisor in the Systems Division. He developed a form for the submission of vital information on scheduled water main shutdowns. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Jeanette A. Roache	City Council	\$ 50	Ms. Roache is a Council Representative in Councilman Murphy's Office. She suggested that an emergency contact number be posted above the in-house telephones located in the basement, the lobby and the terrace level of the City Administration Building. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Michael D. Shea	Fire	\$ 25	Mr. Shea is a Fire Fighter. He suggested that several safety improvements be made to fire apparatus #1247. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Steven W. Zeiss	General Services	\$ 25	Mr. Zeiss is an Electrician in the Buildings Division. He suggested that the emergency lighting system in the City Administration Building be rearranged due to the recent remodeling in the building. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
