BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City a modification to the City's contractual agreement with the San Diego Regional Employment and Training Consortium (RETC) to extend the period of performance for the Street Youth Program for six months, from January 1, 1983 through June 30, 1983, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 257535 .

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$70,000 from the 1982 CDBG Contingency Reserve (Fund 18518) is hereby authorized and the City Auditor and Comptroller is authorized to transfer said \$70,000 within Fund 18518 from Department 5619, Organization 1901 (Contingencies) to Department 5614, Organization 1408 (Street Youth Program) to be used together with a \$70,000 RETC allocation solely and exclusively for the purpose of providing funds for the above program.
