BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of TITLE INSURANCE AND TRUST COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of November 2, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 257557, granting to said City an easement for public street purposes in a portion of Pueblo Lot 1264 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named UPPER HILLSIDE DRIVE.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
