RESOLUTION NUMBER R- 257567

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Mira Mesa Boulevard, affecting Lot 87 of Lusk Industrial Park Unit 3; and

WHEREAS, the Engineering and Development Department has requested that the City revest these abutter's rights of access in the property to LUSK/MIRA MESA, a limited partnership, to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, a fee of Four Hundred Fifty Dollars (\$450) has been received to cover the processing of this request; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the Mayor and the City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of The

City of San Diego, a quitclaim deed to LUSK/MIRA MESA, a limited partnership, as tenants of Lot 87 of Lusk Industrial Park Unit 3, effecting the revestment of those abutter's rights of access to Mira Mesa Boulevard of Lot 87 of Lusk Industrial Park Unit 3 heretofore relinquished to the City, as more particularly described in that quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 257567 .

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the quitclaim deed and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
