
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the First Amendment to Agreement with Community Medical Center, a non-profit corporation, to increase the construction budget by Three Thousand Dollars (\$3,000) from Forty-Seven Thousand Dollars (\$47,000) to Fifty Thousand Dollars (\$50,000) for the renovation project at 5079 Logan Avenue, San Diego, California, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 257575.

BE IT FURTHER RESOLVED, that the transfer of Three Thousand Dollars (\$3,000) from CDBG Fund 18517, Dept. 5994, Org. 9401 (Contingencies) to Fund 18517, Dept. 5987, Org. 8706 is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure in the sum of Three Thousand Dollars (\$3,000) from CDBG Fund 18517 for this amendment, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
