
WHEREAS, in approving the final map of HYE PARK subdivision, the City shall receive easement interests which will allow the quitclaim of existing sewer and water easements within the area of the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value and will serve the same purpose as those easements being quitclaimed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR- 257590, quitclaiming to HYE INVESTORS, a general partnership, all the City's right, title and interest in the sewer and water easements, as more particularly described in said quitclaim deed.
