WHEREAS, Sections 8330, et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution; and

WHEREAS, portions of street reservations on Lots 207 and 208 of Mesa Hills Unit No. 3, Map No. 3769 have never been used for the purpose for which they were acquired and are no longer needed for present or prospective public use; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That portions of street reservations in Lots 207 and 208 of Mesa Hills Unit No. 3, Map No. 3769, as more particularly shown on Drawing No. 15635-B, on file in the office of the City Clerk as Document No. RR- 257589-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

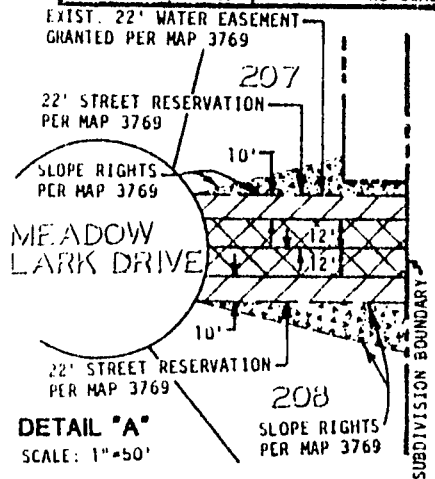
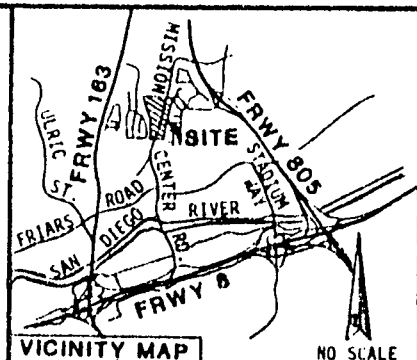
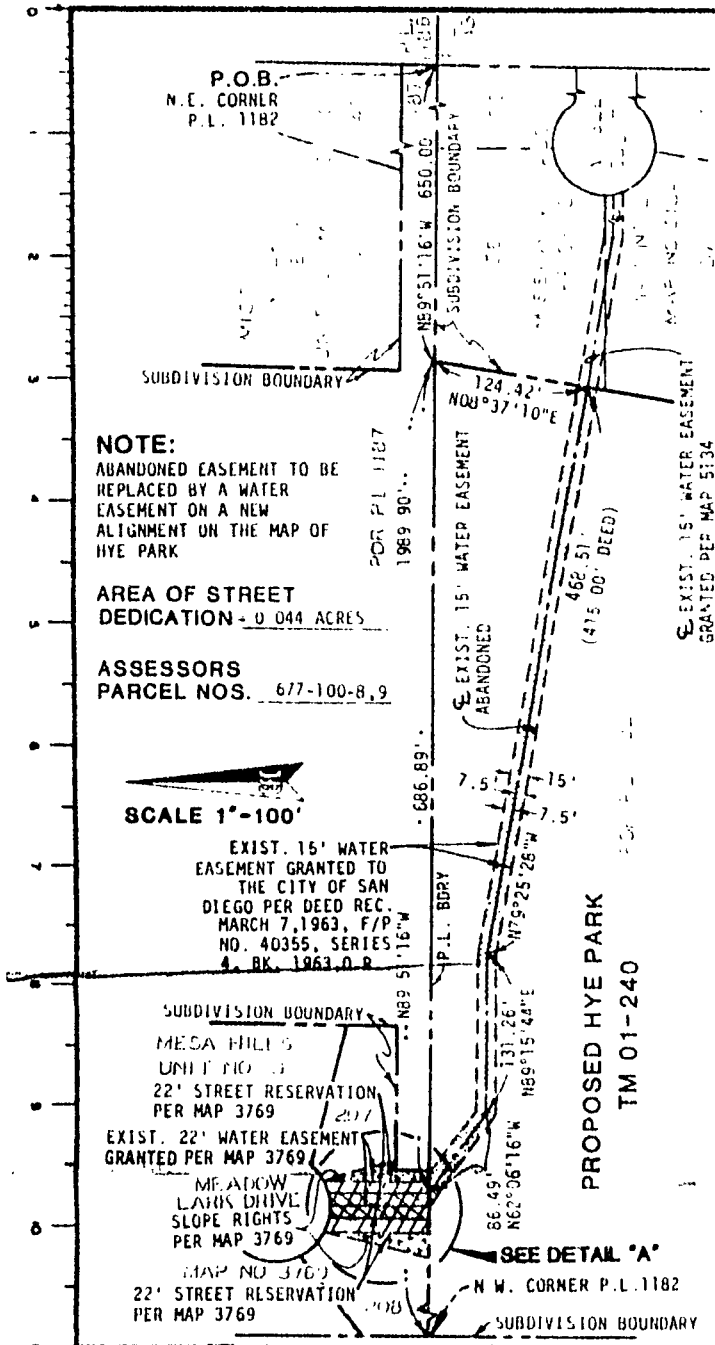
