

RESOLUTION NUMBER R- 257595

Adopted on DEC 6 1982

WHEREAS, Council Policy 000-18, entitled "Sister City Program" provides that the International Affairs Board shall be the agency of the City which makes recommendations to the Council concerning establishment of additional sister city relationships; and

WHEREAS, the City presently enjoys sister city relationships with Yokohama in Japan, Cavite City in the Philippine Islands, Leon in Mexico, Tema in Ghana, and Edinburgh in Scotland; and

WHEREAS, Dr. Leon Sinder appeared before the International Affairs Board (herein called "Board") on April 14, 1982 to request that a sister city relationship be established with Jeonju, Korea; and

WHEREAS, the Board screens and evaluates various requests for all sister city affiliations; and

WHEREAS, the matter was considered by the Board's sister city subcommittee to determine whether the requirements of Council Policy 000-18 have been met; and

WHEREAS, that subcommittee reported to the Board that all the criteria of Council Policy 000-18 had been fulfilled, stressing, however, that the proposed Jeonju Sister City society must not rely on the City of San Diego for monetary support and must be, in effect, self-sufficient as are San Diego's other sister city societies; and


WHEREAS, the Board accepted the subcommittee's report and recommends to the Council the establishment of a sister city relationship with Jeonju, Korea; and

WHEREAS, the Mayor of Jeonju has also indicated his desire that a sister city relationship be established; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the recommendation of the International Affairs Board to establish, for and on behalf of the citizens of San Diego, a sister city relationship with the City of Jeonju, Korea, is hereby approved.
