RESOLUTION NUMBER R- 257597

Adopted on DEC 6 1982

WHEREAS, on November 14, 1983, the Council Committee on Public Services and Safety unanimously approved an allocation of \$1,000 of Transient Occupancy Tax Funds to the Spirit of '76 Booster Club; and

WHEREAS, said funds are to be used to help send the Patrick Henry Marching Band to the 1983 Tournament of Roses Parade and promote the City of San Diego; and

WHEREAS, it is necessary to execute an agreement with the Spirit of '76 Booster Club to effectuate said event and a letter agreement has been prepared which requires authorization for execution by the City Manager; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a letter agreement with the Spirit of '76 Booster Club, to provide the sum of \$1,000 for the purpose of helping send the Patrick Henry Marching Band to the 1983 Tournament of Roses Parade and promote the City of San Diego, pursuant to the terms and conditions of

the letter agreement, dated November 29, 1982, on file in the office of the City as Document No. RR-257597, said funds to come from the Transient Occupancy Tax Fund 10223, Program 91509.
