That the acceptance by the City Manager of that street easement deed of ENCELIA PARTNERS, a general partnership, executed in favor of The City of San Diego, bearing date of August 2, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 257625, granting to said City an easement for public street purposes affecting the southwesterly 10 feet of Lot 2, Block F of La Jolla Country Club Heights, Map 1975, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named ENCELIA DRIVE.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
