That the acceptance by the City Manager of that deed of ENCELIA PARTNERS, a general partnership, executed in favor of The City of San Diego, bearing date of August 2, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 257626, relinquishing to said City any and all abutter's rights of access in and to La Jolla Park, as established by Ordinance No. 11289, adjacent and contiguous to a portion of Lot 2, Block F of La Jolla Country Club Heights, Map No. 1975, and Pueblo Lot 1264 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved.
