

RESOLUTION NUMBER R- 257634

Adopted on DEC 13 1982

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby commends Gregory T. Smith, Chairman of the Ad Hoc Golf Advisory Committee, and members William Carrol, Robert Dille, Bernard J. Goodbody, Bob Gutwein, Marge Harter, Bob Pastore and Vic Tufford for their civic generosity in serving on the Committee and diligently pursuing the review of the fee structure of City-operated golf courses as directed by the Public Facilities and Recreation Committee on May 20, 1981.

BE IT FURTHER RESOLVED, that the recommendations of the Ad Hoc Golf Advisory Committee, as amended by the Public Facilities and Recreation Committee on October 6, 1982, except as they relate to monthly tickets and to the waiver of fees for the Andy Williams San Diego Open, are hereby adopted; and the City staff is hereby directed to implement them as soon as possible.

BE IT FURTHER RESOLVED, that there shall be a monthly discount ticket available only to residents of the City of San Diego at both Torrey Pines and Balboa Park Golf Courses, at the monthly rate of \$18 for the Balboa 9-hole course and \$26 for the 18-hole courses at both sites, which fees shall be adjusted annually to account for inflation. The residents' monthly ticket shall permit those City residents 18 years of age and under and 62 years of age and older unlimited rounds of golf per month during weekdays only, and a limit of 10 rounds of golf per

month during weekdays only for those who are 19 through 61 years of age.


BE IT FURTHER RESOLVED, that green fees for the Andy Williams San Diego Open shall be waived only if a certified, audited deficit is incurred in connection with the event, in which case the waiver shall not exceed the amount of such deficit.

BE IT FURTHER RESOLVED, that the fees and surcharges for the use of the municipal golf courses located in Torrey Pines Park and Balboa Park contained in the fee schedule dated December 13, 1982, on file in the office of the City Clerk as Document No. RR- 257634, are hereby adopted.

BE IT FURTHER RESOLVED, that Resolution No. 218357, dated May 11, 1977, which established fees and surcharges for the use of the municipal golf courses located in Balboa Park and Torrey Pines City Park is hereby rescinded.

Surcharges: The fee schedule includes surcharges to finance capital improvements. The charge for 9 holes is \$.50. The charge for 18 holes is \$1.00. The charge for 9-hole monthly tickets is \$1.25; the charge for 18-hole monthly tickets is \$2.25.

\*Monthly tickets: Monthly ticket holders 19 through 61 years of age are entitled to play 10 weekday rounds per month. Student (18 years and under) and senior (62 years and over) monthly ticket holders are entitled to play one round per day on weekdays only.
