BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for


SOUTH BAY PARK AND RECREATION CENTER GYM FLOOR RECONSTRUCTION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$55,000.00 from PSD Fund 11730 to CIP No. 29-457, SOUTH BAY PARK & RECREATION CENTER GYM FLOOR RECONSTRUCTION.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$55,000.00 from CIP No. 29-457, SOUTH BAY PARK & RECREATION CENTER GYM FLOOR RECONSTRUCTION of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
