GORDON MADISON AND JAMES L. HERMANSON, ATTORNEYS FOR PLAINTIFF in the amount of \$49,505.75, and one made payable to EXECUTIVE LIFE INSURANCE COMPANY in the amount of \$145,602.00, in full settlement of the lawsuit and of all claims.
