APPROVING MAP OF CARROLL RIDGE BUSINESS PARK II.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Douglas C. Paul, a registered Civil Engineer, entitled "CARROLL RIDGE BUSINESS PARK II. Being a subdivision of Parcel 1 in the City of San Diego, County of San Diego, State of California, as shown at page 11683 of Parcel Maps, filed in the office of the County Recorder of San Diego County, September 25, 1981, including Nancy Ridge Drive, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the City of San Diego, a municipal corporation, an easement for open space over, under, and upon portions of Lot 15 as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of the City of San Diego, a municipal corporation, the easement for the natural flowage of waters over, upon, and across the portion of Lot 15 designated as "Flowage Easement Granted Hereon," as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to

endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that the easement for the natural flowage of waters and the open space easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
