That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WESTERN DIVISION POLICE STATION, San Diego, California, filed in the office of the City Clerk of The City of San Diego, California, on December 14, 1982, and bearing official Document No. w.o. 118262, be, and the same are hereby approved.


BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder, subject to the successful sale of Certificates of Participation, for CONSTRUCTION OF WESTERN DIVISION POLICE STATION.

BE IT FURTHER RESOLVED, that the expenditure of \$3,691,000 (\$193,000 from Capital Outlay Fund 30245, CIP 36-029.1, Western Division Police Station, and \$3,498,000 from Certificate of Participation proceeds) is hereby authorized solely and

exclusively for providing funds for said project and related costs, subject to the successful sale of Certificates of Participation, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
