Black Mountain Road and Capricorn Way, both within or adjacent to the Resubdivision of Mesa del Sol Subdivision (TM 02-045) boundaries, as more particularly shown on Drawing No. 20303-D, on file in the office of the City Clerk as Document No. RR- 257661-/, which is by this reference incorporated herein, made a part hereof, be and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the resolution shall not become effective unless and until the Resubdivision of Mesa del Sol Subdivision map has been approved by Council action. In the event that the above condition cannot be met, this resolution shall become void and of no further effect.

BE IT FURTHER RESOLVED, that the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.





VICINITY MAP


