BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The City Council acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, having heard all protests against the acquisition of that property described in that Resolution of Intention No. RR- 257528 adopted by the City Council on November 23, 1982, hereby overrules such protests and determines that the public interest and convenience requires the acquisition of said property for open space park purposes.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to acquire said property through negotiation or at public auction.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$800,000 as payment for said property and related costs from Open Space Park District Bond Fund 79102 is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deed to said property without further Council action.
