RESOLUTION CONSIDERING THE PROTESTS, ORDERING THE DISTRICT FORMED, CONFIRMING THE ASSESSMENT AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE BAYSIDE TERRACES LANDSCAPE MAINTENANCE DISTRICT AS IT PERTAINS TO PARKSIDE MANOS AND GARBER AVENUE.
