

RESOLUTION NUMBER R- 257683

Adopted on JUL 15 1982

WHEREAS, section 22.0101 of the San Diego Municipal Code as amended, establishes permanent rules of procedure governing the operation of the Council; and

WHEREAS, Rule 10 of said section establishes four standing committees of the City Council; and

WHEREAS, Rule 13 of said section, as amended, provides that the Mayor shall appoint the membership of each committee, subject to confirmation by the Council, except that the Mayor and Deputy Mayor shall serve as permanent voting members of the Rules Committee; and

WHEREAS, Rule 13 provides further that that Mayor shall appoint the chairman and vice chairman of each committee, subject to the confirmation of the Council, except that the Mayor shall serve as permanent chairman of the Rules Committee and the Deputy Mayor shall serve as permanent vice chairman of the Rules Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to section 22.0101, as amended, of the Municipal Code of The City of San Diego, the following appointments by the Mayor to Council committees as indicated for terms commencing December 16, 1982 and ending December 4, 1983, are hereby confirmed:


