

Walters and Sons, Inc., for the painting of the Sunset Cliffs Bridge over the San Diego River Floodway, said contract having been filed in the office of the City Clerk as Document No. RR-257686, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract of \$108,000.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$108,000 from Fund 3220, for contract change orders and project contingencies for the cleaning and painting of Sunset Cliffs Bridge over San Diego River Floodway is hereby authorized, solely and exclusively for the purpose of providing additional funds for the above project.
