RESOLUTION NUMBER R-257687

Adopted on December 20, 1982

WHEREAS, the Council representative for District 4 in the City of San Diego was elected to the San Diego County Board of Supervisors; and

WHEREAS, as a result of said election and the resignation of the incumbent on December 14, 1982, a vacancy in the office of District 4 Councilmember was created; and

WHEREAS, Section 12 of the Charter of The City of San Diego requires said vacancy to be filled by the remaining Councilmembers within 30 days after the vacancy occurs or else cause a special election to be held to fill the vacancy; and

WHEREAS, the remaining members of the Council chose to select a person from the district to fill said vacancy, as mandated by Section 12 of the Charter to hold office only until the next regular municipal election, at which date a person shall be elected to serve for the remainder of such unexpired term, should there be any; and

WHEREAS, the City Council, pursuant to the procedure agreed upon for selection and appointment, unanimously agreed upon a candidate to fill said Council vacancy; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the authority vested in the Council by Section 12 of the Charter of The City of San Diego, this Council does

hereby appoint William D. Jones to the office of Councilman for District 4 in The City of San Diego, effective this 20th day of December 1982.
