BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. UNIVERSITY FORD and 2. CARL BURGER DODGE are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS TRUCKS AND VANS as follows:


1. UNIVERSITY FORD - for Item 1, one (1) each station wagon (Ford LTD station wagon) at a cost of \$9,954.00; Item 3, one (1) each cargo super van (Ford E-250 super cargo van) at a cost of \$10,437.00; Item 6, two (2) each cargo vans (Ford E-150 cargo van) at a cost of \$8,850.00 each; Item 7, one (1) each cargo van (Ford E-250 super cargo van) at a cost of \$11,000.00; for a combined total of \$49,091.00; terms net 20 days, plus sales tax, less trade-in allowance as follows:
