AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 31.0131 AND 31.0140 RELATING TO BUSINESS LICENSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Chapter III, Article 1, Division 1, of the San Diego Municipal Code be and it is hereby amended by amending Sections 31.0131 and 31.0140 to read as follows:

SEC. 31.0131 FEES--TIME OF PAYMENT

Except as otherwise provided, licenses shall be due and payable at the following times:

- (a) Annual licenses on the first day of the month following the expiration date;
- (b) Semi-annual licenses on the first day of January and the first day of July of each year;
- (c) Quarterly licenses on the first days of January, April, July and October of each year;
- (d) Monthly licenses on the first day of each and every month;
- (e) Daily licenses in advance on each day.

 All licenses shall be valid for the period issued.

Any person who fails to pay the amount required on or before the fifteenth (15th) day following the due date will be assessed a penalty of 25% of the license tax amount.

SEC. 31.0140 WRITTEN STATEMENTS REQUIRED AT TIME OF APPLICATION

Where the license fee is based upon the number of persons employed, the applicant at the time of applying for a license shall file a written statement showing the average of the number of persons employed on the prior January 1 and the prior June 30. Written statements shall be on forms provided by the City Treasurer.

Remainder of paragraphs - No change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
