AN ORDINANCE INCORPORATING A PORTION OF LOT 1, FORDSVILLE SUBDIVISION, MAP NO. 5472, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11206 (NEW SERIES), ADOPTED JANUARY 1, 1974, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That a portion of Lot 1, Fordsville Subdivision, Map No. 5472, in the City of San Diego, California, designated "M-1A" on Zone Map Drawing No. B-3541, be, and it is hereby incorporated into M-1A Zone as described and defined by Section 101.0436.

Section 2. That Ordinance No. 11206 (New Series), adopted January 10, 1974, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
