AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 2,
DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTIONS 42.0163 AND 42.0164 RELATING TO
MOBILE FOOD UNITS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 2, Division 1 of the San Diego Municipal Code be and it is hereby amended by amending Sections 42.0163 and 42.0164 to read as follows:

SEC. 42.0163 MOBILE FOOD UNITS--CONSTRUCTION
AND EQUIPMENT REQUIREMENTS

A. through Q. - No change.

R. Nothing contained in this section shall be construed to prevent the Director from establishing lower or less stringent requirements or specifications than those contained herein in such cases where a mobile food unit may be maintained at such lower or less stringent requirements or specifications in a sanitary condition without detriment to the public health or safety.

SEC. 42.0164 MOBILE FOOD UNITS--CONSTRUCTION AND
EQUIPMENT REQUIREMENTS FOR UNITS UPON
WHICH UNPACKAGED FOODS ARE CARRIED

A. through F. - No change.


G. Nothing contained in this section shall be construed to prevent the Director from establishing lower or less stringent requirements or specifications than those

contained herein in such cases where a mobile food unit may be maintained at such lower or less stringent requirements or specifications in a sanitary condition without detriment to the public health or safety.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
