AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0550, SUBSECTION D, RELATING TO SIDEWALK CAFES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0550, Subsection D, to read as follows:

SEC. 101.0550 SIDEWALK CAFES

- A., B., and C. No changes.
- D. ADMINISTRATION AND ENFORCEMENT
 - 1. Administration.

The Planning Director or his designated representative shall review, approve, conditionally approve or disapprove all applications for Sidewalk Cafes permits.

2. Requirements for Application.

Application for a Sidewalk Cafe Permit shall be made to the Planning Department according to the following procedures:

a. Application for a Sidewalk Cafe

Permit shall be made by the owner or owners

of the property on which the development is

proposed. The application is to be filed

with the Planning Department on the

appropriate form accompanied by adequate plans for improvements and a legal description of the property.

- b. The applicant shall pay a deposit as required by SEC. 101.0204 of the San Diego Municipal Code.
- c. The application shall be accompanied by plans indicating: The proposed use, materials, and design; relationship of proposed encroachment to the curb, existing buildings, and buildings on either side; floor plans of the existing building; location of utilities that might affect or be affected by the proposal; existing and proposed public improvements; existing or projected pedestrian traffic movements.

E., F., G., H., and I. - No changes.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
