AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6 OF  
THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION  
86.09.04 RELATING TO FIRE APPARATUS ACCESS  
ROADWAYS.

BE IT ORDAINED, by the Council of The City of San Diego, as  
follows:

Section 1. That Chapter VIII, Article 6 of the San Diego  
Municipal Code be and is hereby amended by adding Section  
86.09.04 to read as follows:

SEC. 86.09.04 PARKING OR STANDING IN FIRE APPARATUS  
ACCESS ROADWAYS


No person shall park or stand any vehicle on public or  
private property in a Fire Apparatus Access Roadway where  
signs prohibiting the obstruction of such roadway have been  
posted pursuant to Section 55.10.207 of this Code.

This prohibition against parking or standing vehicles  
in designated Fire Apparatus Access Roadways shall be  
operative twenty-four (24) hours a day (Sundays and  
holidays included).

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
