## ORDINANCE NUMBER 0-15916 (New Series) Adopted on MAR 7 1983

AN ORDINANCE AMENDING ORDINANCE NO. O-15750 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1982-83" BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE NEW CLASSIFIED POSITION OF PRINTING SERVICES SUPERVISOR AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

WHEREAS, the Purchasing Department requested a study of an existing supervisory position in the Print Shop because of significant changes in duties; and

WHEREAS, the Personnel Department conducted a study of the position and recommended the creation of a new class entitled Printing Services Supervisor; and

WHEREAS, on January 6, 1983, the Civil Service Commission considered and approved the creation of a new classification of Printing Services Supervisor in the Classified Service of The City of San Diego; and

WHEREAS, the Commission at the same January 6, 1983 meeting also considered and recommends to the City Council the establishment of a schedule of compensation for the newly created position; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-15750 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1982-83" be and the same is hereby further

amended by amending Exhibit B thereto to create and establish the classified position of Printing Services Supervisor.

Section 2. As a schedule of compensation for the position created in Section 1 above, the following standard rate number of the Table of Classes and Standard Rates is hereby established and adopted.

Section 3. The position of Printing Services Supervisor shall be inserted in Exhibit B to Ordinance No. O-15750 (New Series), as amended, under the general category of PRINTING in front of the position of Offset Press Supervisor.

Section 4. The Auditor and Comptroller is hereby directed to amend, as necessary, Exhibit A to Ordinance No. 0-15750 (New Series), as amended, by calculating and inserting in said Base Salary Table, the following new rate:

Section 5. Pursuant to Section 8 of Ordinance No. O-15750 (New Series), as amended, the above newly created position, with the concurrence of the Civil Service Commission and City Manager, shall be and is hereby designated to be eligible for premium rate overtime. The Personnel Director is hereby directed to include such designation in the Personnel Manual of The City of San Diego.

Section 6. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
