AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 5, DIVISION 17, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 85.06 TO PROVIDE FOR AN APPEAL TO THE TRANSPORTATION LAND USE COMMITTEE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 85.06 of the San Diego Municipal Code be amended to read as follows:

SEC. 85.06 VARIATION OF STATE SPEED LIMIT

(a) Whenever the City Manager determines, upon the basis of an engineering and traffic survey that a speed greater than 25 miles per hour would facilitate the orderly movement of vehicular traffic and would be reasonable and safe upon any street otherwise subject to a prima facie limit of 25 miles per hour under the Vehicle Code, the City Manager may determine and declare a prima facie speed limit of 30, 35, 40, 45, 50, 55, or 60 miles per hour, or a maximum speed limit of 65 miles per hour, whichever is found most appropriate to facilitate the orderly movement of traffic and is reasonable and safe, which declared prima facie speed limit shall be effective when appropriate signs giving such notice thereof are erected upon said street.

No change in paragraphs (b) through (c).

(d) Any Councilmember may file a request with the City Clerk for a review of the determination of a speed

limit set pursuant to subsection (a) or (b) of this section.

The City Clerk shall immediately transmit a copy of said request to the Committee Consultant who shall thereupon set a time and place for the hearing and shall so notify the requesting Councilmember. The hearing shall be held within thirty (30) days after the request is filed. At the hearing, the Councilmember may present evidence in support of his contentions. Any interested persons may be allowed to participate in the hearing and present evidence. After the conclusion of the hearing the Transportation and Land Use Committee of the City Council may, based upon the engineering and traffic survey, sustain or modify in whole or in part the Manager's determination. If the committee modifies in whole or in part, the City Manager's determination, it shall make findings as to the appropriate speed limit and the reasonableness thereof based upon the engineering and traffic survey. The decision of the Committee shall be final unless a hearing is set before the City Council pursuant to Section 22.0101,

Rule 4.

2. This ordinance shall be in full force and effect thirty days from and after its passage.
