AN ORDINANCE SETTING ASIDE AND DEDICATING A PORTION OF PUEBLO LOT 1803 OF THE PUEBLO LANDS OF SAN DIEGO, AND A PORTION OF LOTS "C" AND "D" IN BLOCK 7 OF MISSION BEACH, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Pueblo Lot 1803 of the Pueblo Lands of San Diego, and a portion of Lots "C" and "D" in Block 7 of Mission Beach, in the City of San Diego, County of San Diego, State of California, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

EXHIBIT A PARCEL 8 (Mission Beach Park)

- 1. All that portion of Pueblo Lot 1803 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the Office of the San Diego County Recorder, November 14, 1921, as Miscellaneous Map No. 36, more particularly described in Parcels A and B as follows:
 - Α. Beginning at the intersection of the Westerly prolongation of the North line of San Fernando Place with the West line of Ocean Front Walk, as said rights-of-way are located and established as of the date of this instrument; thence Southerly along said West line of Ocean Front Walk and its Southerly prolongation to the intersection with the North right-of-way line of the North Jetty of Mission Bay, as located and established as of the date of this instrument; thence Westerly along said North right-of-way line of the North Jetty to the intersection with the Mean High Tide Line of the Pacific Ocean. as said tide line is delineated on Miscellaneous Map No. 201, filed in the San Diego County Recorder's Office, October 7, 1948; thence Northerly along said Mean High Tide Line to the intersection with the Westerly prolongation of said North line of San Fernando Place; thence Easterly along said Westerly prolongation returning to the Point of Beginning.
 - B. Beginning at the intersection of the Westerly prolongation of the North line of Santa Rita Place with the West line of Ocean Front Walk, as said rights-of-way are located and established as of the date of this instrument; thence Southerly along said West line of Ocean Front Walk to the intersection with the Westerly prolongation of the South line of Ventura Place, as located and established as of the date of this instrument; thence Westerly along said Westerly prolongation to the intersection with the Mean High Tide Line of the Pacific Ocean, as said tide line is delineated on Miscellaneous Map No. 201, filed in the San Diego County Recorder's Office, October 7, 1948; thence Northerly along said Mean High Tide Line to the intersection with the Westerly prolongation of said North line of Santa Rita Place; thence Easterly along said Westerly prolongation returning to the Point of Beginning.
- 2. All that portion of Lots "C" and "D" in Block 7 of Mission Beach, in the City of San Diego, County of San Diego, State of California, according to Maps thereof Nos. 1651 and 1809, filed respectively in the Office of the San Diego County Recorder, December 14, 1914, and November 13, 1924; together with a portion of former Ocean Front Walk, now vacated and closed to public use, immediately adjoining said lots on the Southwest, and a portion of Pueblo Lot 1803 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the Office of the San Diego County Recorder, November 14, 1921, as Miscellaneous Map No. 36, more particularly described as follows:

PARCEL 8 (Mission Beach Park)- Continued

Commencing at the most Westerly corner of Lot "B" in said Block 7 of Mission Beach; thence South 54°32'16" East, a distance of 50.00 feet to the TRUE POINT OF BEGINNING; thence continuing South 54°32'16" East, 23.19 feet to the North right-of-way line of the North Jetty of Mission Bay, as located and established as of the date of this instrument; thence along said North right-of-way line North 81°50'22" East, 79.31 feet to a point on the arc of a 1,694.69-foot radius curve, concave Northeasterly, a radial to said point bears South 39°49'17" West; thence leaving said North right-of-way line Northwesterly along the arc of said curve through a central angle of 02°23'17", an arc length of 70.63 feet to a point of intersection with the arc of a 34.00-foot radius curve, concave Northwesterly, a radial to said point bears North 77°05'49" East; thence Southerly, Southwesterly, and Westerly along the arc of said curve through a central angle of 94°44'33", an arc length of 56.22 feet; thence South 81°50'22" West, 15.27 feet returning to the TRUE POINT OF BEGINNING.

EXCEPTING THEREFROM any portion lying below the Mean High Tide Line of Mission Bay, False Bay, or the Pacific Ocean.
