AN ORDINANCE SETTING ASIDE AND DEDICATING LOTS 25 AND 26 IN BLOCK 5, LOTS 33 TO 48, INCLUSIVE, IN BLOCK 6 AND LOTS 35, 36 AND 37 IN BLOCK 22 OF CITY HEIGHTS, AND LOT 20 IN BLOCK "M," LOTS 1 AND 2 IN BLOCK "O," LOT 23 IN BLOCK "Q," AND LOTS 3, 4 AND A PORTION OF LOT 2 IN BLOCK "R" OF MONTCLAIR, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Lots 25 and 26 in Block 5, Lots 33 to 48, inclusive, in Block 6 and Lots 35, 36 and 37 in Block 22 of City Heights and Lot 20 in Block "M," Lots 1 and 2 in Block "O," Lot 23 in Block "Q" and Lots 3, 4 and a portion of Lot 2 in Block "R" of Montclair, in the City of San Diego, County of San Diego, State of California, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

EXHIBIT A  
PARCEL 9  
(Montclair Park)

All those portions of City Heights and Montclair, in the City of San Diego, County of San Diego, State of California, according to respective Maps thereof Nos. 1007 and 1684, filed respectively in the Office of the San Diego County Recorder, October 3, 1906, and March 20, 1916, more particularly described in Parcels 1 through 7 as follows:

1. Lots 25 and 26 in Block 5 of said City Heights, together with those portions of vacated Nile Street and vacated Quince Street, if any, lying adjacent to said lots.
2. Lots 33 to 48 inclusive in Block 6 of said City Heights. EXCEPTING THEREFROM that portion of Block "O" of said Montclair lying therein.
3. Lots 35, 36, and 37 in Block 22 of said City Heights. EXCEPTING THEREFROM that portion of said Lot 37 described in deed to the State of California, filed in the San Diego County Recorder's Office, April 29, 1966, File/Page 66-72084.
4. Lot 20 in Block "M" of said Montclair.
5. Lots 1 and 2 in Block "O" of said Montclair. EXCEPTING THEREFROM that portion of Lot 2 dedicated and named Nile Street by San Diego City Council Resolution 129992, November 30, 1955, and depicted on San Diego City Engineering Department Drawing 9488-B.
6. Lot 23 in Block "Q" of said Montclair.
7. Lots 3, 4, and a portion of Lot 2 in Block "R" of said Montclair, said portion of Lot 2 being described in deed to the City of San Diego, filed in the San Diego County Recorder's Office, March 6, 1972, File/Page 72-54058.
