AN ORDINANCE SETTING ASIDE AND DEDICATING A CERTAIN UNNUMBERED TRACT OF LAND DESIGNATED AS "PARK," AND THE NORTH 660.00 FEET OF THAT CERTAIN UNNUMBERED TRACT OF LAND DESIGNATED AS "PARK," BOTH IN THE LITTLE LANDERS SUBDIVISION OF SAN YSIDRO, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That a certain unnumbered tract of land designated as "Park," and the North 660.00 feet of that certain unnumbered tract of land designated as "Park," both in the Little Landers Subdivision of San Ysidro, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1174, filed in the Office of the County Recorder of San Diego County April 10, 1909, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

PARCEL 13
(San Ysidro Community Park)

- A. All that certain unnumbered tract of land designated as "Park" in the Little Landers Subdivision of San Ysidro, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1174, filed in the Office of the County Recorder of San Diego County, April 10, 1909, being bounded on the North by Seaward Avenue, on the West by West Park Avenue, on the East by East Park Avenue, and on the South by Hall Avenue, as said streets are located and established on said Map 1174.

EXCEPTING THEREFROM any portion of the San Diego & Arizona Eastern Railway Company right-of-way, 100.00 feet wide, lying therein.

- B. The North 660.00 feet of that certain unnumbered tract of land designated as "Park" in the Little Landers Subdivision of San Ysidro, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1174, filed in the Office of the County Recorder of San Diego County, April 10, 1909, being bounded on the North by Hall Avenue, on the West by West Park Avenue, on the East by East Park Avenue, and on the South by San Ysidro Boulevard (formerly Tia Juana Boulevard), as said streets are located and established on said Map 1174; said North 660.00 feet being measured at right angles to the West line of said "Park."
