AN ORDINANCE ABANDONING AN UNNEEDED SEWER EASEMENT IN PORTIONS OF BLOCK 387, OLD SAN DIEGO AND IN PUEBLO LOT 1101 OF THE PUEBLO LANDS OF SAN DIEGO, AND RESCINDING SECTION 2 OF ORDINANCE NO. 5295 (NEW SERIES).

WHEREAS, the vacation of the City's interest in an unneeded sewer easement affecting portions of Block 387, Old San Diego and Pueblo Lot 1101, as more particularly described in the legal description attached hereto as Exhibit "A", has been proposed; and

WHEREAS, the herein-described easement has not been used during the past five years and is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the sewer easement, as more particularly described in the legal description attached hereto, is hereby vacated.

Section 2. That Section 2 of Ordinance 5295 (New Series), adopted August 14, 1952, which set aside the above-described easement, be and it is hereby rescinded.

Section 3. That the City Clerk of said City be, and he is

hereby authorized and directed to cause a certified copy of this ordinance, attested by him under seal, to be recorded in the office of the County Recorder.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
