AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 4 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 62.0413 RELATING TO CITY COUNCIL CONSIDERATION OF APPEALS FROM DECISIONS OF THE PLANNING COMMISSION OR CITY ENGINEER AND AMENDING CHAPTER X, ARTICLE 1, DIVISION 5 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0550 RELATING TO SIDEWALK CAFES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Division 4 of the San Diego Municipal Code be and it is hereby amended by amending Section 62.0413 to read as follows:

SEC. 62.0413 CITY COUNCIL CONSIDERATION OF APPEALS
FROM DECISIONS OF THE PLANNING COMMISSION
OR CITY ENGINEER

- (a) No change.
- (b) In the event that anyone is dissatisfied with any decision of the City Engineer, an appeal as provided for herein may be directed to the Committee of the City Council having jurisdiction over such matters at the time of the appeal by filing a notice thereof with the City Clerk within fifteen (15) days following such action. Appeals shall be filed in writing with and on forms provided by the City Clerk. Such appeals shall state the nature and basis

of the appeal. The City Clerk shall immediately transmit a copy of said notice to the Committee Consultant who shall place the matter on the Committee docket for a hearing within fifteen (15) days or at the next succeeding regular Committee meeting unless the applicant consents to a continuance.

Last paragraph - No change.

Section 2. That Chapter X, Article 1, Division 5 of the San Diego Municipal Code be and it is hereby amended by amending Section 101.0550 to read as follows:

SEC. 101.0550 SIDEWALK CAFES

A., B., C., D., E. and F. - No change.

## G. OTHER APPLICABLE REGULATIONS

## 1. Encroachment Permit.

An Encroachment Permit shall be required for a sidewalk cafe according to the provisions of Municipal Code, SEC. 62.0301 et seq. and shall be applied for and processed concurrently with the application to the Planning Director for a Sidewalk Cafe Permit. An appeal from the decision of the City Engineer will be made to the Committee of the City Council having jurisdiction over such matters at the time of the appeal. Such appeal shall be governed by the provisions of Municipal Code SEC. 62.0413(b).

If an appeal is filed within the time specified, it shall automatically stay proceedings in the matter.

2., 3., 4., 5., H. and I. - No change.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
