AN ORDINANCE SETTING ASIDE AND DEDICATING LOTS 8 AND 9 IN BLOCK F AND A PORTION OF BLOCK G, STARKEY'S PROSPECT PARK, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "STARKEY MINI-PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Lots 8 and 9 in Block F and a portion of Block G, Starkey's Prospect Park, in the City of San Diego, County of San Diego, State of California, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named STARKEY MINI-PARK.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Legal Description

Starkey Mini-Park

1. Lots 8 and 9 in Block "F" of Starkey's Prospect Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1729, filed in the Office of the San Diego County Recorder, May 6, 1922.
2. All that portion of Block "G" of Starkey's Prospect Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1729, filed in the Office of the San Diego County Recorder, May 6, 1922, more particularly described as follows:

Beginning at the Southwesterly corner of Lot 9, Block "F", said Starkey's Prospect Park; thence Southeasterly along the Southeasterly prolongation of the Westerly line of said Lot 9, being also the Westerly line of said Block "G", a distance of 50.00 feet; thence Northeasterly along a line 50.00 feet distant from and parallel with the Southerly line of said Lot 9, a distance of 101.67 feet to the intersection with the Southwesterly prolongation of the Easterly line of said Lot 9; thence Northeasterly along said Southwesterly prolongation to the Southeasterly corner of said Lot 9, a distance of 60.13 feet; thence Southwesterly along the Southerly line of said Lot 9, a distance of 160.00 feet returning to the Point of Beginning.
