AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SAN DIEGO STADIUM AUTHORITY TO ISSUE REVENUE BONDS

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The San Diego Stadium Authority, organized under that certain agreement dated January 25, 1966, and entitled "Joint Exercise of Powers Agreement Between the City of San Diego and the County of San Diego Creating the San Diego Stadium Authority," as amended, is hereby authorized to issue revenue bonds as described herein pursuant to the provisions of Article 2, Chapter 5, Division 7, Title 1 of the Government Code (commencing with Section 6540).

Section 2. The maximum amount of bonds proposed and authorized to be issued by the Authority is \$13,000,000.

Section 3. The project to be funded by the bonds is the construction of additional plaza level seating and approximately forty-four sky boxes at the San Diego Jack Murphy Stadium. The project will result in an increase in seating capacity at the Stadium of approximately 7,700 seats.

Section 4. The anticipated source of revenue to redeem the bonds hereby authorized is increased rental payments under a master lease dated February 24, 1966, as amended, between the City of San Diego and the San Diego Stadium Authority.

Section 5. The City Clerk is hereby directed to cause

publication of notice of the adoption of this ordinance for five (5) consecutive days in the San Diego Daily Transcript, a daily newspaper of general circulation published and circulated in the City/County of San Diego, as required by Government Code Section 6040.1 within fifteen (15) days from the passage hereof pursuant to Government Code Section 6547.2.

Section 6. This ordinance is subject to the provisions for referendum contained in Section 3751.7 of the Elections Code. Subject to those provisions, this ordinance shall take effect and be in force sixty (60) days from the date of its adoption and, prior to the expiration of fifteen (15) days from the passage hereof, the City Clerk shall cause this ordinance to be published at least once in the San Diego Daily Transcript, a daily newspaper of general circulation published and circulated in the City of San Diego.
