ORDINANCE NUMBER O- 15957 (New Series)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO PURSUANT TO SECTION 99 OF THE CHARTER OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO THE JOINT EXERCISE OF POWERS AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND THE COUNTY OF SAN DIEGO CREATING THE SAN DIEGO STADIUM AUTHORITY AND PROVIDING FOR NOTICE AND A PUBLIC MEETING IN CONNECTION THEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The San Diego Stadium Authority intends to issue additional revenue bonds the proceeds of which will be used to construct certain improvements to the San Diego Jack Murphy Stadium.

Section 2. In order to provide for such improvements, it is necessary to amend that certain agreement between the City of San Diego and the County of San Diego entitled "Joint Exercise of Powers Agreement Between the City of San Diego and the County of San Diego Creating the San Diego Stadium Authority," dated as of January 25, 1966 (the "Agreement").

Section 3. An Amendment Number 1 to the Agreement in form and substance substantially similar to the form of amendment attached hereto is hereby approved.

Section 4. The Mayor of the City of San Diego is hereby authorized to execute said amendment on behalf of the City of San Diego, with such additions thereto and deletions therefrom as the Mayor shall approve.


Section 5. On March 28, 1983, at 2 o'clock p.m., at 202 "C" Street in the City of San Diego, the City Council of the City of San Diego shall hold a public meeting to consider said Amendment Number 1 to the Agreement.

Section 6. The Clerk of the City of San Diego is hereby directed to publish this Ordinance in the San Diego Daily Transcript, the official newspaper for the City of San Diego, fifteen (15) days prior to the adoption hereof, and at least ten (10) days prior to the public meeting referred to above, and such publication shall constitute notice of the public hearing as required by Section 99 of the Charter of the City of San Diego.

Section 7. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
