AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING DIVISION 8, SECTIONS 42.0801 THROUGH 42.0807, RELATING TO HAZARDOUS WASTE ESTABLISHMENTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 2, of the San Diego Municipal Code be, and the same is hereby amended by adding Division 8, Sections 42.0801 through 42.0807, to read as follows:

DIVISION 8

HAZARDOUS WASTE ESTABLISHMENTS

SEC. 42.0801 FINDINGS AND PURPOSE

It is the intent of the Council that the Health Officer establish a program to monitor establishments where hazardous wastes are produced, stored, handled, disposed of, treated, or recycled. It is further the intent of the Council that the Health Officer provide health care information and other appropriate technical assistance on a 24-hour basis to emergency responders in the event of a hazardous waste incident involving community exposure.

SEC. 42.0802 HEALTH PERMIT REQUIRED

Health regulated businesses shall include business establishments where hazardous wastes or extremely hazardous wastes are produced, stored,

handled, disposed of, treated, or recycled. Such businesses shall be referred to in this ordinance as hazardous waste establishments. A separate health permit shall be required for each such establishment. SEC. 42.0803 ENFORCEMENT

The Health Officer, in addition to his or her other duties, is hereby designated as the officer to enforce the provisions of the State Hazardous Waste Control Law and the minimum standards of management of hazardous and extremely hazardous waste as specified in Chapter 30, Division 4, Title 22 of the California Administrative Code pertaining to the safe production, storage, handling, disposal, treatment and recycling of such waste.

SEC. 42.0804 INSPECTIONS

It shall be the duty of the Health Officer to make periodic inspections of all hazardous waste establishments where hazardous waste and extremely hazardous waste are produced, stored, handled, disposed of, treated, or recycled.

SEC. 42.0805 REPORTING

The Health Officer is hereby empowered to request all persons believed by him to be owners or operators of hazardous waste establishments to, within thirty (30) days, complete a form specifying the person's name, address and information concerning general hazardous waste management activities.

SEC. 42.0806 CHANGE OF BUSINESS ADDRESS OR NAME

Owners and operators of permitted hazardous waste establishments shall report in writing any change of business address or change of business name. The report shall be filed with the Health Officer within thirty (30) days of any such change.

SEC. 42.0807 FEES

Every person applying for a permit under the provisions of this division shall at the time of making application for such permit pay a fee, the exact amount which shall be determined by the County of San Diego and kept on record by the County Department of Health Services and on file in the City Clerk's Composite Rate Book. The schedule of fees shall include provisions for collection of annual renewal fees and collection of delinquency fees. The imposition of or payment of the penalty imposed by this section shall not prevent the imposition of any other penalty prescribed by this code or any ordinance or prosecution for violation of this code or any ordinance.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 2.

OF THE SAN DIFGO MUNICIPAL CODE BY ADDING DIVIBION 3, SECTIONS 42.001 THROUGH 42.007, RELATING TO HAZARDOUS WASTE ESTABLISHMENTS.

This ordinance imposes a permit requirement for establishments which produce, store, handle, dispose of, treat or recycle hazardous or extremely hazardous wastes. The Health Officer is designated as the officer to enforce the State Hazardous Waste. Control Law and the associated minimum s'andards specified in the California Administrative Code. Periodic inspections by the Health Officer of each such establishment are also authorized by this ordinance.
