LEGAL DESCRIPTION

Parcel 1

A strip of land 5.00 feet wide lying contiguous to and Westerly of the Westerly line of 65th Street as said street is located and established on January 13, 1983 all lying within a portion of Lot "D" and Lot 28 of Encanto according to Map thereof No. 749 filed in the Office of the County Recorder of San Diego County.
