ORDINANCE NUMBER O- 15969 (New Series)

Adopted on MAY 9 1983

AN ORDINANCE AUTHORIZING AN AGREEMENT WITH VARIOUS PARTICIPATING HEALTH CARE INSTITUTIONS AND A TRUST AGREEMENT IN CONNECTION WITH THE ISSUANCE OF CITY OF SAN DIEGO HOSPITAL REVENUE BONDS (EQUIPMENT FINANCING PROGRAM) IN A PRINCIPAL AMOUNT NOT TO EXCEED \$30,000,000.

WHEREAS, the City Council of The City of San Diego (the "City"), acting under and pursuant to the powers reserved to the City under Sections 3, 5 and 7 of Article XI of the Constitution of the State of California and Section 2 of the Charter, and The City of San Diego Health Facility Revenue Bond Law (herein called the "Law"), constituting Article 7 of Chapter IV of the Municipal Code of the City has provided for the issuance of its hospital revenue bonds to fund an equipment financing program; and

WHEREAS, the City Council finds that the public interest and necessity require the City to enter into loan agreements with the various hospitals which will participate in said equipment financing program funded with the proceeds of said bonds and an indenture between the City and a corporate trustee setting forth the terms of said bonds and providing for the payment and security thereof; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City Manager and other proper officers of the City are authorized to prepare and to enter into for and in the name and on behalf of the City in accordance with The City of San Diego Health Facility Revenue Bond Law, agreements in substantially the same form as the form of agreement on file in the office of the City Clerk as Document No. 00-15969-1 with various hospitals located in the City providing for loans to such hospitals to be funded by the issuance of hospital revenue bonds of the City in a principal amount not to exceed \$30,000,000 and for a term not to exceed forty years, and an indenture in substantially the same form as the form of indenture on file in the office of the City Clerk as Document No. 00-15969-2 between the City and a corporate trustee setting forth the terms of said bonds and providing for the payment and security thereof, and all necessary and appropriate documents in connection therewith; provided, however, that the final form of said agreements and of said indenture shall be submitted to the Council for approval by resolution prior to their respective execution by the City.

Section 2. The City Clerk is hereby authorized and directed to cause a digest or a copy of this ordinance to be published at least once in "The San Diego Daily Transcript" within fifteen days after its final passage pursuant to Section 18 of the Charter.

Section 3. This ordinance shall take effect and be in

force on the thirtieth day from and after its passage.
