AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 7 OF THE SAN DIEGO MUNICIPAL CODE (THE CITY OF SAN DIEGO HEALTH FACILITY REVENUE BOND LAW) BY ADDING SECTION 47.0311 RELATING TO POOLED EQUIPMENT FINANCINGS.

WHEREAS, The City of San Diego (the "City") is a municipal corporation and charter city duly organized and existing under the Constitution and laws of the State of California, pursuant to which the City has the right and power to make and enforce all laws and regulations in respect to municipal affairs and certain other matters in accordance with and as more particularly provided in Sections 3, 5 and 7 of Article XI of the Constitution of the State of California and Section 2 of the Charter of the City (the "Charter"); and

WHEREAS, the City Council of the City, acting under and pursuant to the powers reserved to the City under Sections 3, 5 and 7 of Article XI of the Constitution of the State of California and Section 2 of the Charter, has previously enacted The City of San Diego Health Facility Revenue Bond Law (the "Law") establishing the procedures for the authorization, sale and issuance of revenue bonds by the City for the purpose of providing financing to certain health institutions for certain purposes as specified therein; and

WHEREAS, the City Council of the City now finds that the public interest and necessity require amendment of the Law to authorize the financing of equipment acquisition by certain

health facilities on a pooled basis; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 7 of the San Diego Municipal Code be and it is hereby amended by adding Section 47.0311 to read as follows:

SEC. 47.0311 POOLED EQUIPMENT FINANCINGS

Notwithstanding any provision in this article to the contrary, the City may, from time to time, issue bonds to finance the equipping of health facilities pursuant to this article. Such bonds may be secured from revenues received from one or more participating health institution and shall contain such provisions and be issued on such terms as are otherwise contained in this article.

Section 2. The City Clerk is hereby authorized and directed to cause a digest or a copy of this ordinance to be published at least once in "The San Diego Daily Transcript" within fifteen days after its final passage pursuant to Section 18 of the City Charter.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
