AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.0104, RELATING TO COST OF INVESTIGATION AND FEES OF POLICE REGULATED BUSINESSES.

BE IT ORDAINED, by the Council of The City of San Diego as, follows:

Section 1. That Chapter III Article 3, Division 1, of the San Diego Municipal Code be and it is hereby amended by amending Section 33.0104 to read as follows:

SEC. 33.0104 COST OF INVESTIGATION AND FEES

It is the policy of the City of San Diego that the cost of a license or permit application investigation and processing, and appeal hearing, as well as required enforcement of police regulated businesses, shall be borne by the applicant, licensee or permittee and current costs shall be reflected in the fees required for such license or permit.

Unless otherwise specified, all original applications for City business licenses which are designated as police regulated shall be accompanied by a nonrefundable fee which will cover the cost of any investigation deemed necessary by the Chief of Police.

Where a fee or sum of money is referred to in this Article, the exact amount of such fee or sum of money shall be found in the City Clerk's composite rate book. Where a

fee or sum of money is required to recover costs incurred in enforcement of any of the provisions of this Article, the City Manager shall establish the appropriate amount of the fee which shall be maintained in the City Clerk's composite rate book in order to recover the City's actual costs incurred in providing required enforcement of the provisions of this Article.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
