AN ORDINANCE AMENDING ORDINANCE NO. 0-15780 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1982-83 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15780-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING SECTION 2., SUBSECTION 4. TO ADD UNDER FUND 18011, A NEW LINE ITEM ENTITLED "LOCAL MATCH - URBAN DEVELOPMENT ACTION GRANT" IN THE SUM OF \$1,200,000; DIRECTING THE TOTAL FISCAL YEAR 1983 REVENUE SHARING BUDGET BE INCREASED TO REFLECT THE \$1,200,000 INCREASE IN FUND 18011.

WHEREAS, on April 19, 1983, the City Council directed the City Manager to initiate the necessary actions to appropriate and encumber \$1,200,000 in General Revenue Sharing Funds to be committed as the local match for an Urban Development Action Grant (UDAG) application for the renovation of the U. S. Grant Hotel; and

WHEREAS, the funds are currently available in the General Revenue Sharing Trust Fund; and

WHEREAS, it is necessary to amend the Annual Appropriation Ordinance to effectuate this action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15780 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1982-83 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby amended by amending Document No. 00-15780-1, as

amended and adopted therein, by amending Section 2., subsection 4. to add under Fund 18011, a new line item entitled "LOCAL MATCH - URBAN DEVELOPMENT ACTION GRANT" in the amount of \$1,200,000.

Section 2. The Auditor and Comptroller is hereby directed to increase the appropriation indicated in the total fiscal year 1983 Revenue Sharing Budget to reflect the \$1,200,000 increase in Fund 18011 for Local Match-Urban Development Action Grant.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
