AN ORDINANCE AMENDING SECTIONS 2 AND 6 OF ORDINANCE NO. 8985 (NEW SERIES), ADOPTED MARCH 24, 1964, EMPOWERING THE CITY MANAGER TO ISSUE REVOCABLE PERMITS AUTHORIZING THE PLACEMENT OF PUBLIC TELEPHONES ON THE PUBLIC SIDEWALKS OF THE CITY OF SAN DIEGO AND SETTING FORTH THE CONDITIONS OF APPROVAL OF SUCH PERMITS.

WHEREAS, The City of San Diego and the Pacific Telephone
Company desire to revise the terms under which the City Manager
issues permits for the placement of public telephones on the
public sidewalks of the City; and

WHEREAS, the terms under which such permits are issued are contained in Ordinance No. 8985 (New Series); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Section 2 of Ordinance No. 8985 (New Series), adopted March 24, 1964, be, and it is hereby amended to read as follows:

## Section 2. DEFINITIONS

- (c) "Total Gross Receipts": Any and all compensation in lawful currency of the United States collected or received, or in any manner gained from public telephones placed upon public sidewalks, excepting the federal communications excise taxes.

Section 2. That Section 6 of Ordinance No. 8985 (New Series), adopted March 24, 1964, be, and it is hereby amended to read as follows:

Section 6. PAYMENT TO THE CITY

(a) By its acceptance under Section 4 herein permittee agrees to pay to the City quarterly in lawful currency of the United States the following amount of the total gross receipts resulting from operations pursuant to permits authorized under this ordinance:
