66.0124 to read as follows:

SEC. 66.0124 REFUSE DISPOSAL FACILITIES--REGULATIONS

First paragraph and (a) through (h) - No change.

(i) The speed limit on refuse disposal facilities and
on any special access roads thereto shall not exceed a
maximum of 35 miles per hour.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
