AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 101.0601 AND 101.0601.1, RELATING TO PROPERTY DEVELOPMENT REGULATIONS EXCEPTIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 6, of the San Diego Municipal Code, be, and the same is hereby amended by amending Sections 101.0601 and 101.0601.1, as follows:

DIVISION 6
PROPERTY DEVELOPMENT REGULATIONS EXCEPTIONS

SEC. 101.0601 YARDS

- 1. through 3. No change.
- 4. Except in the R-1-10 and more restrictive zones, a detached one-story accessory building, no portion of which is used for living or sleeping purposes, may disregard the above rear yard requirements if not more than 500 square feet in area and not more than 30 feet in total length. Such buildings as herein limited may also disregard interior side yard requirements if placed entirely within the rear 30 percent of the lot or back of the front 70 feet of the lot. An attached one-story accessory building may also disregard interior side and rear yard requirements if located as specified and limited herein and provided that no portion of such building is used for living or sleeping

purposes.

- 5. through 10. No change.
- 11. Entrance canopies above doorways may encroach into front or street side yards when they are constructed in accordance with Municipal Code, Section 91.02.4508.

 SEC. 101.0601.1 LOT COVERAGE

No greater area of any lot in any M-1 or M-2 Zone shall be covered or occupied by residential structures than is indicated in the following table:

Interior	Corner
Lot	Lot
60%	70%

Provided, however, the above allowable lot coverage may be increased ten percent on any lot of less than 2,000 square feet in area if the buildings or structures erected thereon are not more than one story in height.

Entrance canopies shall not be included in the calculation of lot coverage.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
